RENEWAL OF CLEARING AGENT LICENSES 2024

- 1. The Namibia Revenue Agency hereby announces the renewal period for Clearing Agent Licenses. Item 835 of Schedule 8 to the Customs and Excise Act, 1998 (Act No. 20 of 1998) states that the validity period for a Clearing Agent License is from 1 January to 31 December. This means that Clearing Agents are required to renew their licenses issued under the Customs and Excise Act, 1998 before the end of each calendar year, against payment of a renewal license fee of N\$100.
- Pending the gazette of the Rules for the Licensing of Clearing Agents and Direct Trader Inputs (DTIs), Clearing Agents who wish to apply for the renewal of Clearing Agent Licenses for the period 1 January to 31 December 2024 must renew their Clearing Agent Licenses on or before 29 February 2024 by completing the accompanying application form for renewal and submit same to the following office for processing:

The application form for the renewal of Clearing Agent licenses can be obtained from the NamRA Dedicated Service Centre situated at the corner of Robert Mugabe Avenue and John Meinert Street, or from the Division: Trade Facilitation and Customs Procedures on the 1st Floor, West Wing, Townsquare Building or online from www.namra.org.na and must be accompanied by the valid certified copies of identity documents of each director, manager, member, partner or employee(s) of the applicant who will enter or deliver, for reward, bills of entry relating to any goods on behalf of any importer or exporter of goods in terms of section 73 of the Customs and Excise Act, 1998.
- Clearing Agents who fail to renew their Clearing Agent licenses on or before 29 February 2024 will be unable to conduct clearing business for 2024 and we therefore urge all Clearing Agents to comply with this Notice.
